# New teachers' pay, education cuts, working conditions to dominate convention

Unequal pay for newly qualified teachers, the two worst education cuts, and the Croke Park hours are key themes at this year's Annual Convention.

#### **TEACHERS' PAY**

Teachers who entered the profession after 2010 are on different pay scales than their colleagues even though they have the same duties and responsibilities.

Budget 2011 slashed new teachers' pay by 10 per cent. In 2012, most pay allowances above the basic salary scale (e.g. allowance for obtaining a Master's Degree) were abolished for those entering teaching (as well as for new beneficiaries).

While the ASTI has made some progress in having these cuts restored, it still remains that new and recently qualified teachers are placed on inferior pay scales.

Because many newly qualified teachers spend the first few years of their career in temporary and/or part-time teaching positions, they experience the double whammy of a part-time income and an inferior pay scale.

On Tuesday, March 29<sup>th</sup>, three motions will demand the restoration of one common pay scale for all teachers.

#### **Pension levy**

A motion calling for the abolition of the public service pension levy will also be debated on Tuesday, March 29th. This levy has reduced all teachers' pay by up to 7.5%.

#### IMPACT OF EDUCATION CUTS ON STUDENT WELLBEING

On Wednesday, March 30<sup>th</sup> delegates at the ASTI Annual Convention will discuss the impact of cuts to the allocation of guidance counsellors and to posts of responsibility (e.g. Year Head posts) in second-level schools. A survey by Millward Brown in 2013 found:

- Seven in 10 second-level schools have reduced one-to-one guidance counselling for students:
- Almost 60 per cent of principals surveyed stated that the moratorium on posts of responsibility has had a high or medium adverse impact on the wellbeing of students

Delegates will discuss how impositions such as the Croke Park hours and compulsory supervision and substitution are using up time previously available for teaching-related work (e.g. marking and lesson preparation), pastoral care activities, extra-curricular activities.

#### **Junior Cycle – Industrial action over Junior Cycle reform:**

The ASTI is currently engaged in industrial action over the Junior Cycle Framework. ASTI members are prohibited from engaging with aspects of the implementation of the Framework for Junior Cycle, including attendance at CPD for the Framework. The issue will be discussed by Convention delegates on Wednesday, March 30<sup>th</sup>.

#### **News from Convention**

### **CONVENTION MOTIONS 2016**

#### Moratorium on posts of responsibility - Motion 14 -Composite Motion:

That in light of the changed economic circumstances and economic growth, Convention call on the Department of Education and Skills to lift the moratorium on posts of responsibility immediately and restore the number of posts to the pre 2008 level.

(Desmond, Wexford, Galway)

#### Ex-Quota Guidance - Motion 51

That the ASTI seek the full restoration of guidance counselling hours in all second-level schools.

(Limerick North).

#### Common basic pay scale - Motion 1 - Composite Motion:

That in the interests of equality for all its members, the ASTI enter into negotiations with the Department of Education and Skills with the view to restoring a common basic pay scale for all teachers.

(Bray & Dublin South Central)

#### Common basic scale - Motion 5

That the ASTI enter into negotiations with the Department of Education and Skills, prior to the termination of the Haddington Road Agreement, to immediately restore all teachers employed post January 2011 to the common basic pay scale including entitlement to qualification allowances (Wicklow).

#### **Pensions Levy - Motion 21**

That the Public Service Pensions Levy be removed.

#### Sick leave - Motion 48

That the ASTI demand that the DES does not count holiday leave as part of sick leave entitlement.

That the ASTI demand that the DES restore the common basic scale for teachers to the pre-2011 common basic scale for teachers. In the event that this matter is not resolved by 31st August 2016, that the ASTI ballot its members on industrial action, up to and including strike action.

#### Croke Park hours - Motion 39 - Composite Motion

Following the rejection of the Lansdowne Road proposals and in the absence of any consequent agreement by members of the ASTI, that Standing Committee issue a directive to members to cease fulfilling the 33 Croke Park hours upon the completion of the Haddington Road Agreement.

(Dungarvan, Kilkenny, Longford, West Mayo, Wicklow)

Note from Steering Committee: This motion may require a ballot of members.

#### **Continuous Professional Development - Motion 63**

That the ASTI reject any attempt to link Continuous Professional Development and the annual renewal of registration with the Teaching Council.

(Dublin North 1).

#### **Privately paid teachers - Motion 97**

That the A.S.T.I. establish a committee to oversee the pay and working conditions of privately paid teachers and to make policy recommendations in this regard; this committee to report back to Annual Convention 2017. Such committee to be elected at Annual Convention 2016.

(Tipperary)

#### **Continuous Professional Development - Motion 62**

That the ASTI seek to ensure that in the event of compulsory CPD, that it must take place during normal school hours, and that full mileage and subsistence be paid where appropriate

(Athlone)

#### Ballots - Motion 78 - Composite Motion:

That Rule 87 be amended by addition after the words 'postal ballot' of the words 'or school-based ballot as decided by Standing Committee'

#### The Rule will then read:

With a view to deciding matters of policy or of principle, the CEC may take or cause to be taken a plebiscite or ballot of all members of the Association. Plebiscites or ballots of Association members shall be by postal ballot or school-based ballot as decided by Standing Committee. All branches shall, where possible, convene information meetings prior to such plebiscites or ballots

(Kildare, Laois, Navan, West Mayo, Kilkenny, Tuam).

#### **Ballots - Motion 77 - Composite Motion:**

Amend Rule 87 by deletion of the second sentence "plebiscites or ballots of association members shall be by postal ballot" and by insertion of the following new second sentence:

"The format of any plebiscite or ballot of association members shall be by postal ballot or by school based ballot, such format to be decided by CEC".

#### Rule 87 to then read as follows:

With a view to deciding matters of policy or principle, the CEC may take or cause to be taken a plebiscite or ballot of the members of the association. The format of any plebiscite or ballot of association members shall be by postal ballot or by school based ballot, such format to be decided by CEC. All branches shall, where possible, convene information meetings prior to such plebiscites or ballots.
