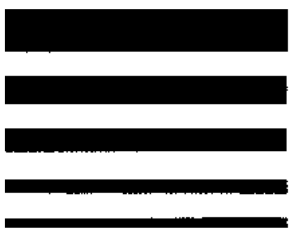

SUBSCRIPTION RATES: DEPT/ETBI Paid teachers in general, subscription rates amount to .76% of your yearly salary. A member receiving a basic salary of €43,925 (gross basic salary) pays .76% of salary, amounting to €333.83 p.a. or approx. €12.81 per fortnight. Any member receiving a basic salary of over €60,658 has their subscription capped at 1.05% of 1st point of pre-2011 salary scale which currently (June 2026) amounts to €461 p.a. or approx. €17.68 per fortnight.
