

SUBSCRIPTION RATES: DEPT/ETBI Paid teachers

In general, subscription rates amount to .76% of your yearly salary. A member receiving a basic salary of €38,637 (gross basic salary) pays .76% of salary, amounting to €293.64 p.a. or approx. €11.26 per fortnight. Any member receiving a basic salary of over €53,289 has their subscription capped at 1.05% of 1st point of pre-2011 salary scale which currently (March 2023) amounts to €405 p.a. or approx. €15.53 per fortnight.
