# ARRANGEMENTS FOR INSPECTORATE ENGAGEMENT WITH POST-PRIMARY SCHOOLS

# September to December 2022

#### SUMMARY

This circular:

- Provides information about the Inspectorate's planned advisory, evaluation and research work in post-primary schools from September to December 2022
- Provides information on the Inspectorate's work on supporting and monitoring the implementation of anti-bullying procedures in schools
- Clarifies the arrangements for school self-evaluation (SSE) for the 2022/23 school year
- Supersedes Circular 0030/2022.

# Introduction

The Inspectorate is strongly committed to evaluating the work of schools and to providing advice and support to schools in a collaborative and respectful way. Our primary focus is on ensuring the best possible education provision for children and young people.

This circular is designed to provide school leaders, teachers and those involved in managing schools with information about the range of activities that the Inspectorate plans to engage in while working with schools in the 2022/23 school year.

The Inspectorate looks forward to continuing its support for the work of schools throughout 2022/23. It will continue with the phased implementation of its inspection programme by extending the current range of inspection activity to involve a wider



range of inspection types. The Inspectorate will also continue to provide advice and support to schools.

# The Inspectorate's planned evaluation and advisory work in schools

#### September to December 2022

From September 2022, the inspection programme will include the following:

- Incidental inspections that are conducted in the context of the school's normal work and are typically unannounced one-day inspection and engagement visits providing opportunities for professional dialogue between school personnel and inspectors
- **Subject inspections** that focus on individual curriculum areas within a school with a view to affirming good practice and making recommendations, where appropriate, to aid the further development of the area
- Child protection and safeguarding inspections (CPSI) that monitor the implementation of the Department's <u>Child Protection Procedures for Primary</u> <u>and Post-Primary Schools 2017</u> in fulfilment of the Minister's obligations under the Children First Act 2015
- Evaluations of provision for students with additional and special educational needs that look in detail at the quality of provision for children with additional and special educational needs
- **Follow-through inspections** to monitor and support the implementation of recommendations arising from previous inspections
- Priority **inspections** in a small number of schools as required. The inspection type will depend on the particular context of the school
- The completion of inspections that commenced in the 2021/2022 school year
- Advisory visits and other activities that will include school self-evaluation advisory visits, visits to schools participating in the Gaeltacht School Recognition Scheme and other advisory visits.

From November 2022, the inspection programme will include evaluations of provision in Special Care Units as well as Programme Evaluations of Transition Year (TY),



Leaving Certificate Applied (LCA) and Leaving Certificate Vocational Programme (LCVP).

#### From January 2023

From January 2023, all other types of inspection, including whole-school evaluations and evaluations of Delivering Equality of Opportunity in Schools (DEIS) action planning will recommence.

The inspection programme will be kept under review in the light of public health advice in relation to COVID-19.

#### Monitoring of anti-bullying

From September 2022, the Inspectorate will continue to monitor and report on the extent to which schools are implementing the <u>Anti-bullying Procedures for Primary and</u> <u>Post-Primary Schools (2013)</u> in all inspection types. During incidental inspections, subject inspections, evaluations of provision for students with special educational needs and follow-through evaluations, the following **three aspects** of the Anti-Bullying Procedures will be monitored:

- The school has developed an anti-bullying policy that meets the requirements of the *Anti-Bullying Procedures for Primary and Post-Primary Schools* (2013) and this policy is reviewed annually.
- The board of management minutes record that the principal provides a report to the board at least once a term on the overall number of bullying cases reported (by means of the bullying recording template provided in the *Procedures*) since the previous report to the board.
- The school's anti-bullying policy is published on its website and/or is readily accessible to board of management members, teachers, parents and pupils/students.

An **additional two aspects** will be monitored during evaluations of special care units, and also during whole-school evaluations and during DEIS evaluations when these inspections recommence in 2023:

• The school has appropriate initiatives in place to promote a positive and inclusive school culture and environment.



• All teachers visited report that they have read the school's policy on antibullying and that they are aware of their roles and responsibilities in preventing and tackling bullying.

Commentary on the extent to which the school is meeting these requirements will be included in all inspection reports.

# Thematic reports

The Inspectorate published two reports recently on the actions taken by schools to prevent and tackle bullying. These are:

The Inspectorate is preparing a report on the findings of incidental inspections conducted during May and June 2022. This report will be published in autumn 2022.

In the September to December 2022 period, research will be conducted in a sample of incidental inspections and subject inspections on areas such as Education for Sustainable Development and Creativity in Teaching and Learning. Reports on this research will be published in 2023.

# School self-evaluation

# Third phase of SSE: 2022-2026

The third cycle of SSE, which had been due to commence in September 2021, will now commence in September 2022. The arrangements for this cycle and the supports for schools are outlined in *School self-evaluation: Next steps, 2022-2026, including Circular 0056/2022 for Primary Schools, Special Schools and Post-Primary Schools* available <u>here</u> on <u>www.gov.ie.</u> The document advises on how schools can develop and use SSE in the years ahead in a way that ensures that school and system goals for equity, inclusion, teaching, learning and wellbeing can be achieved.

#### SSE advisory visits

The Inspectorate will continue to provide school self-evaluation (SSE) advisory visits during the September to December 2022 term as one of a range of supports available



to schools. Schools can apply for an advisory session by emailing <u>SSE@education.gov.ie</u>. In preparation for their advisory session, schools should reflect on the work they have undertaken in SSE to date and consider how they would like the advisory session to progress their engagement in SSE. Advisory sessions will be tailored to the context of each individual school.

#### **Programme for International Student Assessment**

The eighth cycle of PISA, the OECD's Programme for International Student Assessment, due to take place in 2021 and postponed by one year because of the COVID-19 pandemic, will now take place in 2022. PISA measures 15-year-olds' ability to use their reading, mathematics and science knowledge and skills to meet real-life challenges. In line with the Literacy and Numeracy Strategy, all post-primary schools are required to co-operate, when requested, with all national and international surveys approved or commissioned by the Department of Education. Participation in international surveys such as PISA enables the achievement of students in reading literacy, mathematics and science to be benchmarked against international standards.

One hundred and seventy post-primary schools have been selected on a representative basis by the Educational Research Centre (ERC) to participate in PISA 2022 between Monday 17 October and Friday 18 November. Department inspectors will act as Lead Test Administrators (LTAs), alongside support test administrators appointed by the ERC. Each participating school has been asked to nominate a teacher as School Contact who will act as a liaison with the ERC and the Lead Test Administrators. The role of the school contact is to disseminate questionnaire materials to the relevant school personnel and parents in advance of the test date and to put in place the necessary arrangements for the test day in schools. One day substitution cover will be available for teachers who are appointed as school contacts.
